# ABILENE HOUSING AUTHORITY BOARD OF COMMISIONERS MEETING

## March 26, 2015

Mr. Reed reported to the Board that he has moved forward with the contract prior to the board meeting due to time restraints on the repair work. Ms. Amy Pugh, Public Housing Manager then explained where the most damage occurred and how the three complexes were affected.

Commissioner Bennett made a motion to accept Resolution 15-2 with the clarification in the Resolution that the Board is ratifying Mr. Reed having signed the contract on behalf of the Abilene Housing Authority. Commissioner Mukire seconded the motion.

- Public Housing Program "High Performer"- Mr. Reed acknowledged Amy Pugh, Public Housing Manager, for her work in conjunction with the Abilene Housing Authority achieving "High Performer" status for both the REAC inspection and the PHAS assessment.
- Housing Choice Voucher Program "High Performer"-Mr. Reed acknowledged Ellen Gutierrez, HCV manager for her work in conjunction with the Abilene Housing Authority achieving "High Performer" status for the SEMAP score. Mr. Reed also pointed out that this is the 7<sup>th</sup> consecutive year that this status has been achieved.
