In accordance with Texas Government Code, Subchapter D:

(Litigation/Consultation with Attorney) Section 551.071

(Business Prospect/Economic Development) Section 551.087

Synergistic Development PFC may discuss or deliberate on commercial or financial information that has been received from a business prospect that the AHA seeks to conduct economic development negotiations with or deliberate the offer of a financial or other incentive to a business prospect.

(Deliberations about Gifts and Donations) Section 551.073

Synergistic Development PFC may deliberate a negotiated contract for a prospective gift or donation to the Synergistic Development PFC if deliberation in an open meeting would have a detrimental effect on the position of the Synergistic Development PFC in negotiations with a third person.

(Deliberations about Security Devices) Section 551.076

Synergistic Development PFC may deliberate the deployment, or specific occasions for implementation, of security personnel or devices.
